Classes have been scheduled so that most Masters/Excellent dogs will be finished running for the day before the Open and Novice classes begin. Exhibitors should make every effort to limit their time on the trial grounds to the minimum time necessary to prepare for and complete their runs, including measuring if a VMO or AKC Rep is present. Exhibitors who volunteer to work may remain on the trial grounds. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. However, because the gate steward should not be calling exhibitors to the ring by shouting out names of handlers or dogs, and handlers waiting to

run should be exercising social distancing, leeway will be given for exhibitors to make it to the ring for their run. If an exhibitor is not present when first called, they will be allowed to move to the end of their height group and run when called again.

MEASURING and HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official** (**VMO**) or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

Simplified Jump Height Card Process

When filling out the entry form, there is a section at the top of the form for the exhibitor to designate whether your dog needs to be officially measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs to Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

Entering a Mixture of Regular and Preferred Within Same Trial Weekend Multiple Jump Heights Within the Same Trial Day

Effective January 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard and JWW be either both Regular or both Preferred on the same trial day. Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple ump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day. A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of register able breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place outdoors undercover on dirt. Ring size will be 100x100.

FIX AND GO ON (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhiitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. Neither the Weimaraner Club of Albuquerque nor Southwest Agility Team and their agents, employees, etc., will assume any responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Weimaraner Club of Albuquerque and Southwest Agility Team reserve the right to decline entries for cause and

may remove any dog on account of aggression. No one shall have any recourse or claim against the Weimaraner Club of Albuquerque or Southwest Agility Team or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

REFUNDS

- No entry fee will be refunded if the trial cannot open or be completed by reason
 of riots, civil disturbances, fire, an act of God, public emergency, act of a public
 enemy, or any other cause beyond the control of the organizing committee,
 except for cancellation due to COVID-19. It is possible that State government
 restrictions on travel into New Mexico, as well as activities and gatherings within the
 state, may require cancellation of this trial, or cluster of trials, after the closing date. If
 the trial(s) must be cancelled due to the COVID-19 pandemic, full refunds will be
 provided to all exhibitors.

ADDITIONAL SITE INFORMATION

Both Rings will be enclosed by pipe Fencing and netting. Gates that open and Close will be used at the entry and exit of each ring. All contact equipment and tables will have a rubberized surface.

DOGS ARE NOT ALLOWED IN THE RESTROOMS OR ON THE GRASS AREA IN FRONT OF THE POSSE CLUBHOUSE. Any exhibitor failing to comply may be excused from the trial without any refund if the Trial Committee deems the exhibitor to be in violation of this requirement.

This test will be held in a livestock facility. It is possible that there could be livestock in pens adjacent to the rings and crating areas. If your dog is not under reasonable control around livestock, you may not wish to attend this event. Rings will be surrounded by a lightweight netting.

There is ample parking in the large gravel/dirt lot surround the arena. Please do not park or set up crates in the fire zone. No parking spaces may be saved overnight.

No overnight security will be provided. The grounds are fenced and there will likely be RV's parked overnight, but there will be no hired overnight security at this trial site.

CRATING SPACE

Please follow the SWAT SUMMARY OF COVID-19 PROTOCOLS included in this premium.

- Crating spaces must maintain social distancing of at least 6 feet on all sides.
- Any person sitting in a crating space under the arena roof must wear a face covering.
- Crates under the arena roof may not be left overnight, and crating space may not be saved overnight. Instead, exhibitors crating under the arena roof should set up and take down their crating space each day, so that others who run before or after them may also have space to crate with sufficient social distancing.
- Crates and tents set up outside of the arena roof may be left overnight.
- To maintain sufficient social distancing, crating in vehicles is encouraged. Vehicles left with engines or generators running may not be parked adjacent to the arena.

SUMMARY OF COVID-19 PROTOCOLS FOR AGILITY TRIALS AT THE SHERIFF'S POSSE

The full set of protocols can be found on the SWAT website, southwestagilityteam.org.

1. REFUND POLICY.

- a. Who should not attend: any person who has symptoms of COVID-19, who suspects they have been exposed to COVID-19, who has attended another agility trial or large gathering within 14 days of the SWAT trial, or who is concerned for their health or that they will be unable to follow these protocols.
- b. REFUND: any exhibitors who have entered a SWAT trial and decide that they should not attend for any of the above reasons will be eligible for a FULL REFUND of entry fees, as long as the trial secretary is notified before 7:00 am on the first day of the trial.

2. FACE COVERINGS AND SOCIAL DISTANCING.

- a. Exhibitors running in the ring are NOT required to wear a face covering. All other exhibitors, workers, and spectators in the arena, under the roof, including while sitting in the crating area, must wear a face covering. Face coverings must be worn in the restrooms.
- b. Walk-throughs will be limited to twenty exhibitors at a time. Final walk-through groupings will be announced in the final confirmation letter.
- c. Dog/handler teams waiting for their runs must maintain proper social distancing and handlers must wear face coverings until they enter the ring. Because the gate steward will not be shouting to call exhibitors to the gate, leeway will be given for exhibitors to get to the gate.
- Maps, gate sheets, and results will be provided to exhibitors electronically, in a manner announced in the final confirmation letter.
- e. The Gate Steward will have a space at least 6 x 6 feet, marked by tape and located no closer than 6 feet from the gate. Exhibitors will not be allowed in the Gate Steward's area; only the Gate Steward will mark the gate sheets. The Gate Steward will also be responsible for opening and closing the entry gate.
- f. The Leash Runner will use a grabber to pick up leashes left at the start line. The grabber will be cleaned after each leash. Exhibitors are encouraged to carry their leashes during their runs. The leash runner will be responsible for opening and closing the exit gate. Only the Leash Runner with touch the exit gate.
- g. SWAT will provide water for exhibitors, but will not provide snacks or lunches for exhibitors or workers. Workers will be thanked with vouchers that can be used for future trials.
- h. Ribbon stickers and ribbons will be placed on a self-serve table marked by tape so that only one person may be at the table at a time.
- Warm-up jumps will not be fenced. Face coverings must be worn at the warm-up jumps. Hand sanitizer will be made available for use before and after using the warm-up jump.

3. CRATING RESTRICTIONS

- a. Dogs should be crated in their vehicles, weather permitting.
- b. Vehicles with engines or generators running may not be parked adjacent to the arena.
- c. Crating under the arena roof (between the outside and inside fences) is discouraged. All-day workers and Trial Committee members will have priority in choosing to set up crates in this space.
- All crating spaces under the roof must be set at least 6 feet apart. Any person sitting in a crating area under the arena roof must wear a face covering.

- Overnight crating is not allowed and crating spaces cannot be saved or reserved, except for Trial Committee Members and all-day workers.
- f. Crating under the roof, but outside the outer fence, will be allowed only in vehicles, with at least six feet between vehicles and six feet between the outer fence and the vehicle, or chairs set up behind a vehicle.
